**DECLARATION OF RYAN ALDRIDGE  
REGARDING THE STATUS OF NOTICE  
AND SETTLEMENT ADMINISTRATION**

16 I, Ryan Aldridge, hereby declare as follows:  
17

18 **I. INTRODUCTION**

19  
20 1. I am a Project Manager for the Court appointed Claims Administrator,  
21 Postlethwaite & Netterville, APAC (“P&N”). The following statements are based on my personal  
22 knowledge as well as information provided by other experienced employees working under my  
23 supervision.

24 2. I am over the age of 21. Except as otherwise noted, the matters set forth in this  
25 Declaration are based upon my personal knowledge, information received from the parties in this  
26 proceeding, and information provided by my colleagues and our partners.

1 **II. BACKGROUND**

2 3. On April 21, 2023, the Court entered its order preliminarily approving the  
3 Settlement Agreement and the appointment of P&N as Settlement Administrator. After the Court’s  
4 preliminary approval of the Settlement, P&N began to implement and coordinate the notice program.

5 4. I submit this Declaration to evidence P&N’s compliance with the terms of the  
6 Preliminary Approval Order and detail P&N’s execution of its role as the Settlement Administrator.

7 **III. CLASS NOTICE PROGRAM EXECUTION**

8  
9 5. *Notice Database.* P&N maintains a database of 7,513,166 Settlement Class  
10 Members which was used to effectuate the notice campaign as outlined within the Settlement  
11 Agreement (“Class Notice List”). P&N received the class data on April 26, 2023, in one CSV file  
12 from counsel for Defendant containing names and email information for a total of 7,513,918 records.  
13 After reviewing for duplicates based on name and email address, P&N determined that the  
14 Settlement Class consists of 7,513,166 unique records.

15 6. *Email Notice.* Prior to sending the notice by email, P&N performed an email  
16 hygiene verification process designed to protect the integrity of the email campaign and maximize  
17 deliverability. Steps included deduplication, syntax validation, domain validation, and risk  
18 validation. Email addresses for 7,302,158 Settlement Class Members passed the hygiene and  
19 verification process. In sending the Email Settlement Notice, P&N followed standard email best  
20 practices, including utilizing “unsubscribe” links and the Settlement Administrator contact  
21 information. Between May 8, 2023 and May 22, 2023, P&N caused the Email Settlement Notice to  
22 be sent to the 7,302,158 email addresses on the Class Notice List that passed the hygiene and  
23 verification process. The Email Settlement Notice was successfully delivered to 6,887,420 email  
24 addresses, or 94.3% deliverability. Email notice delivery statistics are detailed in Section 10 below.

25 Beginning on June 8, 2023, P&N caused the Email Settlement Notice to be sent a second  
26 time (“Reminder Email Notice”) to the 6,750,966 email addresses on the Class Notice List whose  
27 email was successfully delivered, did not unsubscribe from future emails, and did not submit a claim  
28 or opt-out of the settlement. The Reminder Email Notice was successfully delivered to 6,732,848

1 email addresses, or 99.7% deliverability. A true and correct copy of the Email Settlement Notice  
2 sent to those identified on the Class Notice List is attached hereto as **Exhibit A**. Email notice  
3 delivery statistics are detailed in Section 10 below.

4 7. **Settlement Post Office Box.** P&N maintains the following Post Office Box (the  
5 “P.O. Box”) for the Settlement Program:

10 This P.O. Box serves as a location for the USPS to return undeliverable program mail to  
11 P&N and for Settlement Class Members to submit claim forms, exclusion requests, and other  
12 settlement-related correspondence. The P.O. Box address appears in all Notices and in multiple  
13 locations on the Settlement Website. P&N monitors the P.O. Box daily and uses a dedicated mail  
14 intake team to process each item received.

15 8. **Settlement Website.** On May 8, 2023, a neutral, informational Settlement Website,  
16 www.PricePromotionSettlement.com, was created to provide Settlement Class Members access to  
17 the Long Notice, Printable PDF Claim Form and Exclusion Form, Settlement Agreement, and other  
18 relevant documents. The Settlement Website also includes relevant dates, answers to frequently  
19 asked questions, instructions for how Settlement Class Members may opt-out (request exclusion)  
20 from or object to the Settlement, contact information for the Settlement Administrator, and provides  
21 Settlement Class Members with the ability to submit a claim or exclusion through the Settlement  
22 Website. As of July 14, 2023, the Settlement Website has received 1,756,672 page views from  
23 423,031 unique visitors. The Settlement Website will remain active through the close of this  
24 Settlement Program.

25 9. **Email Support.** P&N established an Email address,  
26 info@PricePromotionSettlement.com, to provide an additional option for Settlement Class  
27 Members to address specific questions and requests to the Settlement Administrator for support. As  
28 of July 14, 2023, P&N received 1,159 emails to the Email address established for the settlement.

1 **IV. NOTICE PROGRAM REACH**

2 10. **Notice Reach Results.** Through the Notice procedures outlined above, P&N  
3 attempted to send direct notice to 7,302,158 (97.19%) Settlement Class Member records whose  
4 email passed the hygiene and verification process. As of July 14, 2023, the Notice Program reached  
5 a total of 6,871,966 (91.47%) of Settlement Class Members. The tables below provides an overview  
6 of dissemination results and reach statistics for the Notice Program.

17 **V. CLAIM ACTIVITY**

18 11. **Claim Intake and Processing.** The online claim submission feature was available  
19 beginning May 8, 2023. As of July 14, 2023, P&N has received 107,047 claim submissions  
20 accounting for 468,092 courses. Based on my experience and the experience of P&N’s team, the  
21 claims rate is in line with the 1% to 5% that is typical for similar consumer class actions<sup>1</sup>. P&N will  
22 continue to intake and analyze claims through the claims filing deadline of July 21, 2023.


**VI. EXCLUSIONS AND OBJECTIONS**

12. ***Exclusions (Opt-Outs) Received.*** The deadline for Class Members to request to be excluded from the Settlement is July 21, 2023. As of July 14, 2023, P&N has received three hundred eighty-seven (387) exclusion requests from Settlement Class Members. A list of all 387 individuals requesting to be excluded is attached hereto as **Exhibit B**.

13. ***Settlement Objections.*** The Settlement Agreement directed that objections be filed with the Court and served on Class Counsel and Counsel for Defendant. The deadline for Class Members to object to the Settlement was July 10, 2023. P&N has not received any objections from Settlement Class Members.

**VII. CERTIFICATION**

**Why did I get this Notice?** A settlement (“Settlement”) has been proposed in a class action lawsuit pending in the Superior Court of California, County of San Diego (“Court”) titled Marion Williams, et al. v. Udemy, Inc. (the “Action”). According to available records, you might be a “Class Member.” The purpose of this Email Notice is to inform you of the Action and the Settlement so that you may decide what steps to take in relation to it.

**What is the Action about?** The Action was filed against Udemy, Inc. (“Udemy” or “Defendant”) by Plaintiff Marion Williams alleging Udemy engaged in deceptive advertising by advertising improper discounts on education courses sold on its e-commerce website, Udemy.com. Udemy denies wrongdoing and liability and both sides disagree on how much, if anything, the Class could have recovered after trial. ***No court has decided which side is right. But both sides agreed to provide benefits to Class Members and resolve the Action.***

**Am I a Class Member?** You are a “Class Member” if you purchased a course or courses from Udemy at a discount based on a Reference Price Promotion during the period of August 23, 2017 through and including April 21, 2023. Excluded from the Class are Udemy’s Counsel, Udemy’s officers and directors, and the judge presiding over the Action.

**What relief does the Settlement provide?** Udemy has agreed to provide a cash payment of four dollars (\$4.00) for every Eligible Course Purchase to each Class Member who timely submits a valid Claim Form by **July 21, 2023** up to \$40.

**What are my other options?** If you don’t want to be legally bound by the Settlement, you must exclude yourself by **July 21, 2023**, or you won’t be able to sue Udemy about the legal claims in the Action ever again. If you exclude yourself, you cannot receive any benefit. If you stay in the Settlement, you may object to it by **July 10, 2023**. The detailed Notice available at [www.PricePromotionSettlement.com](http://www.PricePromotionSettlement.com) explains how to request exclusion or object. The Court will hold a hearing on July 28, 2023 at 1:30 PM to consider whether to approve the Settlement, and a request by the lawyers representing all Class Members (Lynch Carpenter LLP and Keller Postman LLC) for \$1,000,000 in attorneys’ fees, costs, and Individual Settlement Award for the Named Plaintiff (Marion Williams) who will request for \$2,500 for his service. You may ask to appear at the hearing, but you don’t have to.
