PLAINTIFF'S UNOPPOSED MOTION FOR
ATTORNEYS' FEES, COSTS, AND
INCENTIVE AWARDS**

1 On July 28, 2023, this Court heard Plaintiff’s Unopposed Motion for Attorneys’ Fees, Costs, and
2 Incentive Award (the “Motion”) filed by Plaintiff Marion Williams (“Plaintiff”). This Court reviewed the
3 Motion and the supporting papers. As such, having reviewed the foregoing and based on the findings
4 below, the Court found good cause to grant the unopposed Motion.

5 The requested attorneys’ fees and costs in the amount of \$1,000,000 is fair and reasonable in light
6 of the nature of the case, Class Counsel’s experience and efforts in prosecuting this Action,¹ and the
7 significant benefit obtained for Class Members. An Individual Settlement Award in the amount of \$2,500
8 to Plaintiff is fair and reasonable in light of the risks in commencing this Action, and the time and effort
9 spent litigating this action as the Class Representative.

10 NOW, THEREFORE, IT IS HEREBY ORDERED:

11 1. Class Counsel is awarded attorneys’ fees and costs in the total amount of \$1,000,000.
12 Defendant must pay Class Counsel this amount no later than ten (10) calendar days after the Effective
13 Date of Settlement and upon receipt of the relevant Form W-9, as set forth in § III.E(1)(c) of the Settlement
14 Agreement; and

15 2. Plaintiff is awarded an Individual Settlement Award in the amount of \$2,500. Defendant
16 must pay Plaintiff this amount no later than thirty (30) calendar days after the Effective Date of Settlement
17 and upon receipt of the relevant Form W-9, as set forth in § III.E(1)(a) of the Settlement Agreement.
